- Service linefloors through to the mop sink area, including walk in & underneath equipment degreased, deck brushed & mopped. 431
 - Extra utensils removed, washed & boxed to be stored in storage. 295
 - Sanitizer ~~st~~ sink emptied & refilled w/ fresh sanitizer water 294
 - Prep tables cleaned & sanitized as well as prep & dish area walls. 430
 - All employees with facial hair instructed to wear a beard guard at all times during shift. Also posted notice on employee bulletin board.
 - All bus carts, cooler doors & shelves under prep table cleaned & sanitized.
