DATE: 7/30/2019 Action Taken:

Starbucks uses a clean, safe, and ready routine on a daily basis. These routines are done three times a day, AM, MID and PM. They are cleaning tasks we do throughout the day to keep the store safe & clean for our partners and customers.

- All our plates are washed in evening, unless it needs attention right away.
- Soiled towel on counter: Partners are reminded again that if not in use all towels are to be kept in sanitizing water.
- Sticky counter - cleaned up after peak

CRITICAL: 8 Lany company came out - replaced valves on hose for sanitizer. TSSM is required, testing between 200 - 300 ppm
